CDFA Supports 'Revitalizing Downtowns and Main Streets Act'

Federal bill would address vacant commercial real estate while expanding U.S. housing supply

Columbus, OH — The Council of Development Finance Agencies – the nation's largest organization dedicated exclusively to economic and community development finance concerns and interests – has announced its support for the bipartisan "Revitalizing Downtowns and Main Streets Act."

Introduced by U.S. Reps. Mike Carey (R-Ohio) and Jimmy Gomez (D-Calif.), <u>H.R. 9002</u> would create a temporary federal tax credit to encourage the conversion of vacant and underutilized commercial properties into residential housing.

Modeled after the successful Historic Preservation Tax Credit program, the bill would provide a 20% credit in any taxable year for qualified conversion expenditures. For 30 years after a conversion, at least 20% of the residential units in converted buildings would need to be reserved for individuals with incomes at 80% or below the area's median income.

"America's communities are facing a housing shortage," said Toby Rittner, CDFA president and CEO. "At the same time, many commercial properties in urban centers have been at least partially vacant since the start of COVID-19. This legislation is a win-win for communities, families, employers, and developers. CDFA supports this common-sense, bipartisan bill."

A Senate companion bill, <u>S. 4693</u>, has been introduced by U.S. Sen. Debbie Stabenow (D-Mich.).
