As a result, DCA's master agreements with lenders and form templates have been utilized as a model for many other SSBCI programs.

Ms. Hunt is also the manager of the DCA's Georgia Agribusiness and Rural Jobs Act Program and serves as the liaison for the Federal Opportunity Zone Program. Before DCA, Ms. Hunt enjoyed a successful career in the community banking industry and as Chief Financial Officer for Access to Capital for Entrepreneurs (ACE), a CDFI in North Georgia. She also serves on boards of local non-profits and as the Chairman of the White County Chamber of Commerce's Board of Directors.
